- 5. If you are a dependent of your parents, please enclose a copy of their Federal Income Tax Return for the tax year 2014 (page 1, page 2 and all schedules).
- 6. If you are not a dependent of your parents, please enclose a copy of your tax return for 2014.
- If you are an employee of an Accountant, please enclose a letter from your employer, stating their support of your intent to continue your education in accounting.

APPLICATIONS ARE DUE BY APRIL 15, 2015. Incomplete applications will not be reviewed.

The Board of Trustees will meet in May, 2015, to choose the scholarship recipients. Scholarship winners will be notified by June 30, 2015. **Only winners will be contacted.**
